

**JOINT COMMITTEE ON OVERSIGHT OVER THE
INTELLIGENCE-SECURITY AGENCY
OF BOSNIA AND HERZEGOVINA (ISABiH)**



The Committee was established on April 6 2004 as a joint working body of the Parliamentary Assembly of Bosnia and Herzegovina.

It consists of 12 members (six from each House).

The three constitutive peoples are represented in the Committee.

The Committee is headed by the Chairman and the two deputies.

Since its establishment, the Committee has been monitoring the overall activity of the BiH intelligence-security sector reform implementation and through its decisions contributed to the process' satisfactory progress.

Through its work, the Committee gave significant contribution to creating prerequisites for faster BiH entry into the Euro-Atlantic integration process and signing the relevant cooperation agreements.

In its work, the Committee cooperates with all institutions and authorities within the BiH security-intelligence sector as well as with international organizations and institutions, in particular the OSCE Mission to BiH, OHR, EUPM, NATO and DCAF.

Committee's responsibilities are laid down by the Law on Intelligence-Security Agency of Bosnia and Herzegovina, Law on Protection of Secret Data and Rules of Procedure of the two Houses of Parliamentary Assembly of Bosnia and Herzegovina.

In accordance with the mentioned regulations, the Committee has the following responsibilities:

RESPONSIBILITIES

Executes oversight over the legality of work of ISA BiH

Discusses appointment of managing director, deputy and chief inspector

Considers the Report on the work and expenses of ISA BiH

Provides opinion on the ISA BiH budget proposal

Considers reports by the chief inspector on complaints submitted against the Agency

Considers reports by the Chairman of the BiH Council of Ministers on the issues falling within its competence, including measures undertaken with the aim of tackling all problems in ISA BiH identified during the execution of inspection control, audit or investigation

Considers and monitors implementation of BiH intelligence-security policy

Considers laws and other regulations in the area of intelligence-security activities of BiH

Considers issues of BiH international cooperation with other countries and international intelligence institutions

Executes oversight over the application of the Law on Protection of Secret Data by the BiH institutions, entity level bodies and bodies at other governmental levels in BiH

Considers reports by the BiH Ministry of Security and BiH Ministry of Defence on granting permission for access to secret data and security checks
